

IMPOSITION OF UNLOCK 4 IN DISTRICT GURDASPUR.

Whereas Unlock-4 orders under section 144 of Cr.PC was imposed by undersigned to prevent and contain spread of Corona Virus Covid-19 disease vide order no. 17653-17701/MA dated 31.8.2020.

Whereas now Special Chief Secretary, Home, Government of Punjab, Department of Home Affairs and Justice, Chandigarh has issued guidelines vide their letter No. SS/ACSH/2020/612 dated the 9th of September, 2020 in continuation to their previous orders.

Whereas now keeping in view the guidelines issued by Special Chief Secretary, Home, Government of Punjab by aforesaid letter, I Mohammad Ishfaq, IAS, hereby issues the followings orders in territorial jurisdiction of District Gurdaspur under section 144 of Cr.PC of 1973 and Disaster Management Act, 2005, in partial modification to orders issued vide No. 17653-17701/MA /dated 31.8.2020.

"Relaxation in restrictions in urban areas in all the 8 Municipal towns of the District i.e. Municipal Corporation of Batala and Municipal Council Dinanagar, Gurdaspur, Dhariwal, Qadian, Dera Baba Nanak, Shri Hargobindpur, Fatehgarh Churian upto 30.09.2020"

1. Curfew (In Municipalities of the District)

• Sunday Curfew: Total Curfew on Sundays in all the 8 municipal towns of the

District up to 30.09.2020.

Saturday No curfew on Saturdays

 Night Curfew Movement of individuals for all the non-essential activities shall remain prohibited between 09.30 PM to 5:00 AM within municipal limits of all the cities of District Gurdaspur throughout the week.

However, essential activities and services, movement of persons and goods on National and State Highways, inter-state & intra state movement of persons and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and aeroplanes will be permitted. Essential services include services related to health, agricultural and related activities, dairying and fishery activities, banks, ATMs, stock markets, insurance companies, on-line teaching, public utilities, public transport industry in multipleshifts, construction industry, offices both private and government etc.

The Health Care Institutions viz. hospitals, labs, diagnostic centers and chemist shops are hereby allowed to operate on all 7 days of the week throughout the day i.e. will remain open 24X7 and restrictions will not apply.

Movement of persons and students in the connection with all kinds of examinations, admission/entrance tests conducted by Universities, Boards, Public Service Commissions and other institutions shall be permitted.

2. Shops, Restaurants, Hotels, Liquor Vends etc. (for municipalities only) of the District:

3. Vehicles (throughout the District):

- Only 3 persons including driver to be allowed in a 4-wheeler vehicle.
- All buses and public transport vehicles to allow seating for only half (50 %) capacity with no person standing.

4. Ban on gatherings: (throughout the District)

All social, political, religious gathering, protests and demonstrations throughout the District are prohibited.

- (i) Gatherings relating to marriage shall be allowed for only 30 Persons
- (ii) Gatherings related to funeral shall be allowed for only 20 Persons

Strict action shall be taken against the organisers and main participants for violation of orders u/s 144 of Cr.PC.

5. Government and private office in Urban Areas

Government and private offices shall operate with 50% staff strength till the end of the month i.e. not more than 50% of employees would be permitted on a particular day.

The Heads of Offices would restrict public visitors in Government offices and encourage use of on-line Punjab Grievance Redressal System (PGRS) and other on-line tools so as to minimise person to person contact in offices.

The above restrictions are applicable only in urban areas of the District.

In the areas *outside the Municipalities* the following time schedule shall be followed:-
