Whereas Covid-19 restriction orders under section 144 of Cr.pc was imposed by undersigned to prevent and contain the spread of coronavirus Covid-19 disease in the District vide order no. 12285-12330 MA Dated 01.12.2021

Whereas now Principal Secretary (Home), Department of Home Affairs and Justice, Punjab, Chandigarh has issued "Covid-19 Restrictions till 15.01.2022" vide their letter no. 07/56/2020/2H4/1 Dated 01.01.2022.

Whereas now keeping in view of above mentioned guidelines, I Mohammad Ishfaq, IAS, District Magistrate, Gurdaspur, in exercise of powers vested with me under section 144 of Cr. PC 1973 and National Disaster Management Act, 2005 hereby impose following Covid-19 restrictions till 15.01.2022 in territorial jurisdiction of District Gurdaspur.

- 1) Only passengers who are fully vaccinated, or Covid recovered, or with negative RTPCR report of last 72 hrs shall be allowed entry in Punjab. In case a passenger doesn't have either of these, RAT testing shall be mandatory. Passengers travelling by flights shall be mandatorily required to be fully vaccinated, or Covid recovered, or with negative RTPCR of last 72 hrs.
- 2) Gatherings shall be restricted to not more than 500 persons indoor and 700 persons outdoors subject to an upper limit of 50% of the capacity. Artists/ musicians shall be allowed at such functions/celebrations with due COVID protocols.
- 3) Those organizing and managing festival gatherings shall ensure that only that staff is physically present who are either fully vaccinated or have had at least one dose of vaccine over 4 weeks ago. In addition, there shall also a limit to crowd gatherings for any purpose to a maximum of 700 individuals at any given point, with proper COVID appropriate behavior and social distancing norms. These norms shall be mandatory for all crowded gathering including those by political parties for rallies and meetings
- 4) Cinemas and multiplexes are allowed to function with 100% capacity
- 5) All bars, restaurants, spas, swimming pools, coaching centers, gyms, malls, museums, zoos, etc, shall be allowed to operate at 2/3rd of their capacity subject to all staff present being either fully vaccinated or having had at least one dose of vaccine over 4 weeks ago. All users of swimming and gym facilities shall be persons over 18 years who have taken at least one dose of vaccine. Strict COVID protocols shall be put in place for operations.



- 6) Schools (including their playgrounds) shall continue to remain open. However, schools shall allow only those in the teaching and non-teaching staff to resume duties who are either fully vaccinated or have had at least one dose of vaccine over 4 weeks ago. All those with co-morbidities shall only be allowed once they are fully vaccinated. In addition, the school staff must as a precaution be regularly tested in those cases where they have been administered just one dose of vaccine. It is reiterated that testing must be proactively and aggressively done to prevent any outbreaks of the infection. Option of online learning must be available to the students.
 - 7) Colleges, coaching centers and all other institutions of higher learning shall continue to remain open. This shall be subject to the condition that only those teaching/non-teaching staff members and students will be allowed to be physically present who are either fully vaccinated or have had atleast one dose of vaccine over four weeks ago. All those with comorbidities shall only be allowed once they are fully vaccinated. Option of online learning must be available to the students.
 - 8) Teaching and non-teaching staff of colleges, coaching centers, institutions of higher learning, schools shall be prioritized for vaccination with special camps such that all are covered with first dose within this month. Those due for second dose should also be prioritized. Parents of school going children should be encouraged to immediately get vaccinated.
 - 9) Hostels are allowed to open subject to adherence to strict guidelines and advisory as issued by Department of Health and Family Welfare.
 - 10) Department of Women and Child Development shall be allowed to open Anganwadi centres. However, AWCs shall allow only those staff to resume duties who are either fully vaccinated or have had at atleast one dose of vaccine taken over 4 weeks ago. All those with comorbidities shall only be allowed to resume duties once they are fully vaccinated. In addition, the AWC staff must as a precaution be regularly tested in those cases where they have been administered just one dose of vaccine. It is reiterated that testing must be done proactively and aggressively to prevent any outbreaks of the infection.
 - 11) All Government employees may be asked to get themselves administered with covid vaccine within next 15 days, subject to health advisory. If any Government employee fails to get himself/herself vaccinated within next 15 days for any reason other than medical reason, necessary disciplinary action may be initiated against him/her.



12) In addition following will be mandatory :-

- Face covering: Wearing of face cover is compulsory in public places; in workplaces and during transport
- Social distancing: Individuals must maintain a minimum distance of 6 feet (2 gaz ki doori) in public pleaces.

c. No staff of Health Department shall abstain from duty.

Police Authorities shall continue to ensure strict implementation of all the extant directives of MHA / State Government on Covid appropriate behavior, including social/physical distancing, wearing of face masks etc.

Penal Provisions:-

Any violation of these guidelines shall be punishable under section 51-60 of the Disaster Management Act, 2005 beside legal action under section 188 of Indian Penal Code.

Strict compliance of above orders shall be ensured.

This order shall come into force from 01.01.2022, till 15.01.2022.

To contain and manage Covid-19 , in exercise of the powers conferred under section 2 of thee Epidemic Disease Act, 1897 , read with all other enabling provisions of Disaster Management Act, 2005, restrictions imposed vide letter nos. 07/56/2020-2H4/5291 dated 14.10.2021, 07/56/2020-2H4/5441 dated 26.10.2021 and 07/56/2020-2H4/5477 dated 03.11.2021 (Copies enclosed) will remain in force till 15.01.2022.

- In addition following will be mandatory:-
 - Face Covering: Wearing of face cover is compulsory in public places;
 in workplaces; and during transport.
 - Social Distancing: Individuals must maintain a minimum distance of 6
 feet (2 gaz ki doori) in public places.
 Shops will ensure physical distancing among customers.
- No staff of Health Department shall abstain from duty.

Sub: COVID-19 restrictions till 31st October, 2021.

To contain and manage Covid-19, in exercise of the power conferred under section 2 of the Epidemic Disease Act, 1897, read with all other enabling provisions of Disaster Management Act, 2005, following restrictions are imposed till 31st October 2021:-

- Only passengers who are fully vaccinated, or Covid recovered, or with negative RTPCR report of last 72 hrs shall be allowed entry in Punjab. In case a passenger doesn't have either of these, RAT testing shall be mandatory. Passengers travelling by flights shall be mandatorily required to be fully vaccinated, or Covid recovered, or with negative RTPCR report of last 72 hrs.
- b) Gatherings shall be restricted to not more than 400 persons indoors and 600 persons outdoors subject to an upper limit of 50 % of the capacity. Artists/ musicians shall be allowed at such functions/ celebrations with due COVID protocols.
- that only that staff is physically present who are either fully vaccinated or have had at least one dose of vaccine over 4 weeks ago. In addition, there shall also a limit to crowd gathering for any purpose to a maximum of 600 individuals at any given point, with proper COVID appropriate behaviour and social distancing norms. These norms shall be mandatory for all crowded gatherings including those by political parties for rallies and meetings.
 - d) All bars, cinema halls, restaurants, spas, swimming pools, coaching centers, gyms, malls, museums, zoos, etc. shall be allowed to operate at 2/3rd of their capacity subject to all staff present being either fully vaccinated or having had at least one dose of vaccine over 4 weeks ago. All users of swimming and gym facilities shall be persons over 18 years who have taken at

least one dose of the vaccine. Strict COVID protocols shall be put in place for operations.

- e) Schools (including their playgrounds) shall continue to remain open. However, schools shall allow only those in the teaching and non-teaching staff to resume duties who are either fully vaccinated or have had at least one dose of vaccine over 4 weeks ago. All those with co-morbidities shall only be allowed once they are fully vaccinated. In addition, the school staff must as a precaution be regularly tested in those cases where they have been administered just one dose of vaccine. It is reiterated that testing must be proactively and aggressively done to prevent any outbreaks of the infection. Option of online learning must be available to the students. Tehsils/Blocks where positivity is above 0.2% should close primary classes 4 & below until situation improves.
 - f) Colleges, coaching centers and all other institutions of higher learning shall continue to remain open. This shall be subject to the condition that only those teaching/non-teaching staff members and students will be allowed to be physically present who are either fully vaccinated or have had atleast one dose of vaccine over four weeks ago. All those with co-morbidities shall only be allowed once they are fully vaccinated. Option of online learning must be available to the students.
 - g) Teaching and non-teaching staff of colleges, coaching centers, institutions of higher learning, schools shall be prioritized for vaccination with special camps such that all are covered with first dose within this month. Those due for second dose should also be prioritized. Parents of school going children should be encouraged to immediately get vaccinated.
 - Hostels are allowed to open subject to adherence to strict guidelines and advisory as issued by Department of Health and Family Welfare.
 - Department of Women & Child Development shall be allowed to open Anganwadi centres. However, AWCs shall allow only those staff to resume duties who are either fully vaccinated or have had at least one dose of vaccine taken over 4 weeks ago. All those with comorbidities shall only be allowed to resume duties once they are fully vaccinated. In addition, the AWC staff must as a precaution be regularly tested in those cases where they have been administered just one dose of vaccine. It is reiterated that testing must be done proactively and aggressively to prevent any outbreaks of the infection. The tehsils/blocks where positivity is above 0.2 per cent over a week should close AWCs until situation improves.
 - j) All Government employees may be asked to get themselves administered with covid vaccine within next 15 days, subject to

health advisory. If any Government employee fail to get themselves vaccinated within next 15 days for any reason other than medical reasons, necessary disciplinary action may be initiated against them.

District authorities shall also continue to ensure strict implementation 2. of all the extant directives of MHA/State Government on Covid appropriate behaviour including social distancing, wearing of face masks etc.

In addition, there shall also a limit to crowd gathering for any purpose to a maximum of 700 individuals at any given point, with proper COVID appropriate behavior and social distancing norms. These norms shall be mandatory for all crowded gatherings including those by political parties for rallies and meetings.
- 2. Rest of the restrictions will remain the same.
