Sub: Complaint against Jasbir Singh, DSP DERA
BABA NANAK

Kindly treat this as an official complaint against Jasbir Singh, DSP Dera Baba Nanak. Yesterday an incident took place at Village Shahpur Goraya, Tehsil Dera Baba Nanak, District Gurdaspur around 7.30.PM, wherein I got a call from one of my supporters that the mother of Jaggu Bhagwanpuria (a renowned gangster) is roaming around in the Village and had been calling him aswell.

JagguBhagwanpurias mother, has been very active in the Dera Baba Nanak Constituency, wherein she has been going to the houses of Congress Supporters and

making them talk to Jaggu Bhagwanpuria who is lodged in Kurukshetra Jail. When I got a call from my supporter I immediately went to his house wherein three suspicious cars were standing in the lane next to the Gurudwara Shah Goraya the car numbers were **PB 18Z0014, CH01CH2001, PB10FP0380**. When I made a call to the DIG Border Range, Amritsar and the SSP Batala, the DSP was sent to the Village Shahpur Goraya around 8.15PM but instead of going directly to where the cars were parked and where the mother of Jaggu Bhagwanpuria was stationed, the DSP came to the spot where I was sitting. It is when my security personnel informed that he needs to go to the other side of the village, he went to the spot where the cars were standing but instead of checking the suspicious cars, he kept standing outside probably waiting for further instructions. It is only when I made a call to the DIG Border Range, that the DSP is standing outside, the DSP went inside the house where the mother of Jaggu Bhagwanpuria was sitting and thereafter he moved 2 cars from the spot, i.e. **PB 18Z 0014, CH 01 CH 2001**. Thereafter when I went near the spot where the cars were standing and questioned the DSP as to why none of the cars were checked till now, I got a straight answer that "it is not my duty to check cars". Seeing the number of villagers gathered together he wrote down the number from which the mother of Jaggu Bhagwanpuria had been calling and also noted down complaint and again said "now I shall got and check the CAR". It is very
