**Sub:- General elections to Zila Parishads and Panchayat Samitis-2025-
Schedule for updation of electoral rolls- regarding.**

Kindly refer to the subject cited.

2. As per Notification no. P.A.9/1994/S.209/2025/6205 dated 05.08.2025, (copy attached) issued by the Department of Rural Development and Panchayats, the general elections of the members of the Panchayat Samitis and Zila Parishads are to be held by 05.10.2025.

3. As per programme issued by the Commission earlier, vide its letter no. SEC/SA/ZP-PS/DB/2025/603-625 dated 05.02.2025, the final publication of Electoral Rolls for Zila Parishads and Panchayat Samitis had been published on 03.03.2025 by all the Districts. Now, these Electoral Rolls are ordered to be further updated, with qualifying date as 01.09.2025.

4. In this regard, Section 28 of the Punjab State Election Commission Act, 1994, provides for conditions of registration of an elector in the electoral roll of voters as under:-

- S.28 (a) is not less than eighteen years of age on the qualifying date; and
(b) is ordinarily resident in a constituency.

5. You are, therefore, requested that the voter lists published on 03.03.2025 may be further updated as per the following programme:-

6. Above mentioned programme should be adhered to strictly and these instructions must be brought into the notice of all Electoral Registration Officers-cum-Sub Divisional Magistrates.

7. Wide publicity at local level may be done in all the Rural areas covering Zila Parishads and Panchayat Samitis constituencies so that all the eligible voters are given due opportunity.

8. Intimation to the effect that the Electoral rolls have finally been published shall be sent to the Commission.


